GENERAL TERMS AND DIRECTION FOR THE GUIDANCE OF CONTRACT

- 1. Eligible vendors will have to submit copy of Valid Trade license's, GST & PAN and Credential for satisfactory completion of similar nature of job.
- 2. The rate should be quoted after inspection of the site and inclusive of all incidental charges i.e. freight, insurances, labour insurances, handling charges, necessary government taxes, duties etc as well as the Water, Electricity charges which are to be paid as per rules.
- 3. The contractor shall be responsible to ensure compliance with the provision of minimum wages act 1948 as modified up to date and the rules made in respect of any employees, employed by the contractor directly or through the petty or subcontractor for the purpose of carrying this contract. The contractor shall be responsible for any damage, injury or loss caused by the work or workmen to any person, animal or material during the progress of work.
- 4. Liquidated damage will be charged to the contractor if they fail to complete the work within the stipulated time, 0.01% per day to a maximum limit of 05 % of the contract value .
- 5. The allotted time for completion of the work is as specified in the NIQ from the date of receipt of work order .Time is the essence of this contract. Normally no time extension will be granted. In case of prayer for extension of time the University authority has the full right reserved to grant it or discard it.
- 6. The University authority will retain a sum amounting to 10% of the bill of the contract for a period of six months from the date of completion of work as Security Deposit. Which will be released after a period of six months from the date of completion of the work on application.
- 7. Work is to be carried out as per specification laid in the B.O.Q as per instruction of the Civil Engineer.
- 8. The materials brought to site for execution of the work should by no means be taken out of site without the permission of the Engineer.
- 9. The University will not supply any materials to the contractor.

- 10. The contractor will work under the strict supervision of the Engineer.
- 11. The contractor will have to take necessary instruction from the Engineer regarding the execution of work.
- 12. Defect & liability Period :-The defect & liability period will be for a period of six months from the date of completion of the job. Any defects pointed out during this period has to be mend good by the agency at their own cost failing which the retention money will be forfeited.
- 13. The agency should be completed the work within 15 days from issue of the work order.
- 14. University will award the Contract to the bidder whose quotation has been determined to be substantially responsive both technically and commercially. University also reserves the right to reject any or all the tender, wholly or partially, without assigning any reason thereof.
