Note** Duration of all Programmes is 3 Years. [i.e. 6 Semesters]

Eligibility Criteria for Hons. Programmes:

1. Students (Unreserved / OBC- A & OBC- B) who like to pursue any of the above mentioned Programmes except Microbiology (Hons.)* must have to be qualified their 10+2 examinations with the following marks:

Criteria A: - Minimum 60% marks in the subject in which Honours is intended and 50% marks in aggregate at the 10+2 examinations.

Criteria B - If the student does not satisfy criteria A then they should at least possess 55% marks in the aggregate and minimum 45% marks in the relevant subject at the 10+2 examinations in which he / she likes to pursue Honours.

2. Students (SC / ST Category) who seek to pursue any of the above-mentioned Programmes except Microbiology (Honours.) must have to be qualified their 10+2 examinations with the following marks:

Criteria A - Minimum 60% marks in the subject in which Honours is desired and 45% marks in aggregate at the 10+2 examinations.

Criteria B - If the student does not satisfy criteria a then they should at least possess 50% marks in the aggregate and minimum 45% marks in the relevant subject at the 10+2 examinations in which they want to pursue Honours.

*For Microbiology (Hons.), a candidate should have passed the 10+2 examinations with minimum 50% marks in aggregate.

Eligibility Criteria for B.A. Programme :

An applicant must have passed with at least 40% in the aggregate.

NOTE:

English is a mandatory requirement for pursuing any of the above-mentioned Programmes. A student who has not studied and passed with English at the 10+2 examination will strictly not be considered for admission.

Formula for Merit Score Calculation:

Hons. Sub: (2S+T)/6

Programme Course: T/4

S= HONS. SUBJECT

T = (ENGLISH + BEST of 3)

T= (English+ Best of 3)

Best of 3 = Excluding English& ENVS

Best of 3= Excluding English & ENVS

Sample Calculation:

B.SC (MATHEMATICS HONS)

SUBJECTS	OBTAINED MARKS	FULL MARKS
ENGLISH	83	100
BENGALI	86	100
CHEMISTRY	75	100
MATHEMATICS	98	100
PHYSICS	76	100
BIOLOGY	95	100

$$\text{EXAMPLE} = [(2*98) + (83+98+95+76)]/6 = 91.33$$

If the Candidate passed in 2020-

4% will be deducted from merit score.

If the Candidate passed in 2021-

2% will be deducted from merit score.

In case of Education and Sociology, preference shall be given to those applicants who have studied these two subjects in H.S (10+2) level.

Reservation:

A. West Bengal State Higher Education Institutions (Reservation in Admission) Act, 2013, (West Ben Act of X 2013) will be followed in respect of admission of SC/ST/OBC-A/OBC-B and PWD.
